

SUC Ministry & Personnel Report 2024

The Ministry & Personnel (M & P) and Worship Committees were again divided as Diane took over as chair for the Worship committee in 2024. Michèle Ammeter chaired the M & P committee. The work of the 2 committees had not changed in the combined committee, but with someone available to chair the worship committee, the committees were again split.

The Meridian Pastoral Charge Ministry & Personnel committee current Chair is Michèle Ammeter (until Feb 2026) it will then rotate to Sanford. The Meridian M & P committee has not met since the annual meeting.

Rev. James will be in Avonlea every Sunday at 9:30 am and alternating Sundays at Starbuck and Sanford until the end of June. In September 2025 the rotation shifts again, and Rev James is in Starbuck every Sunday.

In 2024, Starbuck services were Sunday at 11:30 am. The second Sunday of the month is a joint service with the Lutheran congregation, and we have lay leaders as needed. While the Meridian M & P committee arranges the schedule for Rev James, Worship committee arranges the schedule of lay leaders for Starbuck.

Rev James continues to complete the basic service and circulates the bulletins for all 3 charges and Starbuck fills in the announcements if they haven't been past to Rev James in time for inclusion, otherwise they are added prior to printing.
